- Specialties held with All Breed and Group shows this provides a financial benefit to specialty clubs. Contact AKC Club Development for help finding potential clubs to work with.
- Using Breed Filter when searching conformation events AKC wants you to use it as it

- V. Report of Treasurer (Kelli) Bank balances for checking and savings were reported.
 - a. Lee Redd, who has been doing our taxes for the last few years, has notified us that he can no longer continue. Since we are a non-profit with less than \$50,000 in receipts, Kelli will be able to file a simple 990N form with the IRS. We have until May 15th (being a non-profit) to file.
 - b. Kelli will retain her position as Treasurer through the end of her term and believes she can do this from her new residence. If checks need depositing, she can find a U.S. Bank nearby.
 - c. Since we have two debit cards, the issue of obtaining a credit card is not being pursued at this time.
 - d. Nancy proposed we advise the membership at the next meeting and start looking for someone with experience with Quick-Books and an accounting background who would like to take on the Treasurer role.

Susan will check with our insurance to be sure that not only is the Board of Directors covered for such an incident, but the event committee as well. This would also extend to any Club event.

 - Finalizing a budget and filling volunteer spots is next.

The Objectives of the Evergreen Golden Retriever Club

a) To preserve the structure, soundness, temperament, natural abilities and personality of the Golden Retriever as described in the breed standard and to do all possible to bring their natural abilities and qualities to perfection.

- b) To urge members and breeders to accept the standard of the breed as approved by the AKC as the only standard of excellence by which the Golden Retriever shall be judged.
- c) To protect and advance the interest of the breed by encouraging sportsmanlike conduct at dog shows, field events, obedience trials and all functions and events where EGRC is being represented.
- d) To conduct sanctioned matches and specialty shows, field events, obedience trials and tracking under the rules of AKC and
- e) To educate members and the public in all aspects of owning a Golden Retriever.
