 Call to order: The meeting was called to order at 7:01 p.m. by Nancy Light, President. Present: Nancy, Marian, Kelli, Pat, Peter, Susan, Amy. Absent: Alice

II. Approval of Minutes:

Motion was made to approve the minutes of the August 2024 Board meeting which were published in the August GW. APPROVED.

III. Report of the President

- Tonight we will review the financial reports of the 2024 Hunt Test and 2024 Agility Trials.
- We will also review the 2024 WC/WCX Budget.
- Slate of officers were sent to the Board from the Nominating Committee. This will be published in the September GW with a reminder that nominations from the floor can be made at the Sept. General meeting.

IV. Report of Corresponding Secretary (Susan)

- Hot topics were posted on the EGRC IO page.
- We still have not received the closing documents from AKC for the Specialty or Hunt Test.
- Report of Treasurer (Kelli) Bank balances for checking and savings were reported.
 - Still waiting for financials from Shari on the Specialty.
 - We did have to send a check to the Springers Club for \$950.62 representing their share
 of the profits from the 2024 Specialty, Still waiting for Shari's report to compare with
 Kelli's spreadsheet of income and expenses.

VI. Report of Committees:

Events:

- Agility (Nancy) August 30-31, September 1, 2024
 - The trials went quite well.
 - Thank you, Susan for covering hospitality duties. Everyone was well fed.
 - A 5-member trial committee was always on site.
 - Lori has secured one judge (Susan Leitner) for next year. We will have less
 expenses since the judge is staying locally with a friend.
 - The double Q rosettes were very popular, and we ended up with one short.
 - A replacement was ordered to be sent out, however it would make more sense to order a supply for the next year or two. Olympic Ribbon Art quoted \$628.01 which should be enough for 2025 and 2026 or \$391.36 for which would be enough for 2025 with a few to spare.
 - After discussion, it was agreed to order the larger quantity.
 - Although the Double Q ribbons are primarily intended for Master Excellent level, it was agreed that it should also be awarded to Novice and Open Double Q.
 - Our entries this year were lower than last year. Impact of NADAC holding their trial outside at Run Wild and the Open UKI being held in Canada could have contributed to the lower entries. Several NADAC exhibitors were sorry they did not sign up for our event as they prefer indoors.

 Another expense was the judge who never signed a contract, and her fee was higher than expected.

 Nancy will let Lori know that we must have a contract in hand from a judge, and if we do not receive it in a timely manner, we will move on to another judge.

MOTION: To appoint Nancy Light as Chair for the 2025 Agility Trials.

APPROVED.

MOTION: To order ribbons at a cost of approximately \$650 for Double Q and new title Rosettes for 2025 and 2026. APPROVED.

- Specialty June 28, 29 2025
 - Maryke is focusing on the venue contract, AKC application, and getting the committee together.
- Judges Selection Committee (Amy) Call for nominations has been sent out to membership.

 - Reviewed the financial report.
 - We had a loss of \$486.85 but should be better next year since the Master National Amateur will not affect our entries and we have a stock of ribbons, poppers, and duck bands which will reduce our expenses.
 - Tri-Club will be having a meeting in the next few weeks to discuss the
 possible purchase of gas guns for long term savings (gas much less expense
 than poppers).
 - PSLRA is not ready to buy gas guns.
 - Tri-Club won't be making the purchase in the near future.
 - Gas guns are not without problems and injuries have occurred.

 - No entries received yet.
 - Nancy and Peter will go to our trailer on Sept. 27th to retrieve the items we need.

 - Exhibitors will have a choice of pins or rosettes.
 - Lisa will be providing lunch for workers and judges.

 - The budget was reviewed.
